

Lake Michigan Junior Golf Tour Registration & Participation Waiver

The applicant and the parent/guardian certify: 1) that the applicant is an amateur player, as defined by the USGA; 2) that the conditions of entry have been read and understood and approval has been granted in submitting his/her entry; 3) that the information given in this application is true to the best of his/her knowledge; and 4) this waiver applies to any 2011 Lake Michigan Junior Golf Tour event that the applicant participates in.

In consideration of the applicant's participation in Lake Michigan Junior Golf Tour tournaments: 1) the applicant and the parent/guardian hereby release the Lake Michigan Junior Golf Tour, The Highlands Golf Club, Chase Hammond Golf Club and all other host sites of Lake Michigan Junior Golf Tour events and all of each company's respective officers, directors, employees, agents, volunteers, parent companies, subsidiaries and affiliates from any and all liability associated either with acts or omissions of such parties, or with accidents or injuries sustained by the applicant or parent/guardian in connection with the tournaments; 2) the applicant grants and assigns his/her individual media/photo rights respecting participation in the competition, without exception to the sponsors, and the Lake Michigan Junior Golf Tour.
